I'm a German expat living in France. After reading Daniel Kahneman, I wanted to do a master's thesis on the psychological aspects of finance. In retrospective I have to say that since then Jean-François Bonnefon has had the biggest influence on my scholarly development. He not only supervised my Masters, and my Ph.D. on socially responsible investments, but also introduced me to Sébastien Pouget and Etienne Mullet.

Today I hold PhDs in Finance and Psychology and have focused my research on how psychological variables influence peoples' financial decisions. I have been teaching a lot of statistics, and finance classes at IAE Toulouse and now at IAE Lyon where I'm currently associate professor of finance. I also favor quantitative methods and in particular experiments. I'm a member of the UNPRI academic network and the FDIR chair. I have published in top-tier journals and have received research grants from the FIR-PRI Finance & Sustainability, the French ANR and the Novéla prize. My Ph.D. Dissertation entitled Experimental Studies on Moral Values in Finance has received the Prix de thèse MSHS-T and the Prix Garrigou.
